ORDER

*Effective January 1, 2012*

COMES NOW the Municipal Judge for the City of Clayton, pursuant to the authority granted by Section 479.050 RSMo, Supreme Court Rule 37.49, and the Ordinances of the City of Clayton, and hereby orders that the following offenses shall be payable through the City of Clayton's Traffic Violations Bureau (TVB). Any offense not listed shall constitute a mandatory court appearance.

The TVB is established as a convenience to the public. It is not intended to replace a court appearance for pleas of **not guilty**. If you believe that you are **not guilty** of the offense charged, you should appear in court on the date indicated on your summons.

If a defendant desires to plead guilty on the following ordinance violations, he/she may mail in, pay in person at Clayton City Hall or pay on line the pre-determined fine (as set forth below) plus court costs. If the TVB receives full payment **3 days prior** to the scheduled court date, the Defendant will not be required to appear in municipal court.

If a defendant is issued **more than one violation** notice, the defendant must appear in court.

Persons 17 years of age and under must appear in court on all offenses with a parent or guardian.
