Application Permit Requirements:

1. \$50 non-refundable **Application Fee**, plus \$100 per **unit fee** charge. Number of units is based on proposed scope of activity. See Right of Way Work Schedule of Fees for additional information. A **Degradation Fee** may also apply.
2. **Five (5) Copies** of a detailed **Site Plan** showing the nature, dimensions and location of the applicant's proposed work and its proximity to the curb, sidewalk, streetlights, street trees and other facilities shall be included with the application. **Proposed disturbance of trees and landscaping within the right-of-way shall be identified on the application.**
3. **Five (5) Copies** of a **Traffic Control Plan** showing the impact of the proposed activity on traffic lanes and pedestrian access mitigation using MUTCD approved traffic control devices.
4. **Certificate of Insurance** in accordance with Section 510.090 of the City of Clayton Rights-of-Way Usage Code.
5. **Performance Bond** in an amount based on scope of activity in accordance with Section 510.060.I of the City of Clayton Rights-of-Way Usage Code. Minimum of \$1,000.

All work is to be completed within thirty (30) days from issuance date of this permit unless otherwise stated on the permit.

Applicant hereby agrees to restore and/or replace, at the discretion of the Director of Public Works, all City owned assets disturbed or affected by any activity associated with the issuance of this permit, and to conduct all activity in accordance with the laws and ordinances of the City of Clayton and the conditions of the permit. **Upon issuance of a Right-of Way Activity Permit, the Department of Public Works shall be notified at (314) 290-8540 at least 48 hours prior to commencing activity for streetlight and traffic signal cable locates.**
